

Sunset Ridge School District 29 2014-15 iPad Accident Protection Plan

Sunset Ridge School District 29 is providing and administering an accident protection plan for students and parents as part of our iPad Learning Initiative. Enrollment in this plan is required for students who wish to take their iPads home. Students who are not enrolled in the plan will check their iPad in and out of the classroom each day. This plan covers "accidental damage" to the device and is designed to limit a family's responsibility for any damage as described in the coverage section below. In addition each device is covered under a manufacturer warranty that covers the normal operation of the device to ensure that it is functioning properly.

Program Rate / Coverage

- \$50 Non-refundable Annual User Fee
- Limit of Liability: \$500.00

Effective Coverage / Expiration Date

- Effective Date: Based on receipt of signed agreement
- Expiration Date: Last Day of School for 2014-2015 School Year or date of un-enrollment from the school district

Coverage

(Subject to Deductible Plan Below)

- **Accidental Damage:** Pays for accidental damage caused by liquid spills, drops, or any other unintentional event.
- **Theft:** Pays for loss or damage of the iPad due to theft. The claim requires a police report to be filed by the family.
- **Fire:** Pays for loss of damage of the iPad due to fire. The claim must be accompanied by an official fire report from the investigating authority.
- **Electrical Surge:** Pays for damage to the iPad due to and electrical surge.
- **Natural Disasters:** Pays for the loss or damage of the iPad caused by natural disasters.

Exclusions

- **Dishonest, Fraudulent, Intentional, Negligent or Criminal Acts:** Will not pay if damage or loss occurs in conjunction with dishonest fraudulent, intentional, negligent or criminal act. The student/parent will be responsible for the full amount of the repair/replacement.
- **Consumables:** Including but not limited to the case/keyboard and chargers.
- **Cosmetic Damage:** that does not affect the functionality of the device. This includes but is not limited to scratches, dents, and broken plastic ports/ parts or port covers.
- **"Jail-breaking"** or otherwise voiding the manufacturer's warranty by altering the software.
- **District 29** is not liable for any loss, damage (including incidental, consequential, or punitive damages) for expense caused directly or indirectly by the equipment.

**If a student is un-enrolled from Sunset Ridge School District for any reason, this protection plan agreement becomes null and void on that date. There are no refunds once this agreement becomes active on the date the iPad is issued. The iPad must be returned on the last day of student attendance.

- I WILL participate in the Sunset Ridge School District's iPad Accidental Protection Plan. I agree to the provisions outlined in the policy terms and understand that:
- Enrollment in the program is required to take the protected device home.
 - The policy only covers the school issued device and does not cover the case/keyboard and cords.
 - This policy does not cover cosmetic damage that does not impair the use of the device. This includes but is not limited to scratches, dents, and broken plastic parts or port covers.
 - A tiered deductible is in place based on annual occurrences. Claims from a prior year are not used in calculating the deductible.
 - Damage as a result of a violation of the iPad User Agreement is not covered. This includes but is not limited to dishonest, fraudulent, intentional, negligent, or criminal acts. Damage to the device is still the responsibility of the student/family.
 - Liability is limited to the replacement/repair of the device; no additional liability is implied or assumed.
 - Jail-breaking the device voids all warranties and is not covered by this policy. "Jail-breaking" is the act of hacking an operating system and removing manufacturer protections in an attempt to modify the device.
 - Covered devices must be in an approved case. Damage that occurs when the device is not housed in the approved case is not covered under this policy.
 - The enrollment rate is non-refundable.

I choose NOT to participate in the Sunset Ridge School District iPad Accident Protection Plan. I understand that my child will still be issued a device for school use, but that it may not leave school property. Intentional damage to the iPad requiring repair is still the responsibility of the student/family.
